SUBJECT: SUMMARY OF CATEGORY 2 PUBLIC MEETING WITH THE NUCLEAR ENERGY INSTITUTE (NEI) AND NUCLEAR POWER INDUSTRIES REGARDING DIVERSITY AND DEFENSE-IN-DEPTH DIGITAL INSTRUMENTATION AND CONTROL ISSUES (TASK WORKING GROUP MEETING)

On October 25, 2007, Nuclear Regulatory Commission (NRC) staff met with representatives of NEI, in a public meeting at NRC headquarters in Rockville, Maryland. Enclosure 1 provides a list of those in attendance and individuals who participated via teleconference. Enclosure 2 is the meeting agenda. Information presented by the NRC and NEI at the meeting is available in the NRC Agencywide Documents Access and Management System (ADAMS) under Accession Nos. ML073190128 and ML073190141.

The purpose of this meeting was to discuss current Digital Instrumentation and Control (DI&C) issues and work on problem resolution relevant to Diversity and Defense-in-Depth.

A public meeting notice was issued on October 9, 2007 and was posted on the NRC's external (public) web page (ADAMS Accession No. ML072820414). Agenda items for the meeting included: Status of White Papers/Comments on the Project Plan; Discussion of Interim Staff Guidance on Diversity and Defense-In-Depth Problem Statements; and, Discussion of Longer Term Issues.

A representative of the NRC opened the meeting which was followed by opening remarks from representatives of both the NRC and NEI.

The finality of the Interim Staff Guidance (ISG) and future potential license applications regarding DI&C were discussed. Methods for capturing lessons learned and providing feedback were also discussed.

The possibility of a joint meeting between TWG #3 Risk Informing DI&C and TWG #2 was discussed.

Representatives of the NEI indicated that they welcomed participating in this meeting of TWG #2 and discussed a possible target date to revise the ISG. Representatives of the NRC responded and indicated that there was no target date to issue revisions to the ISG. Additionally, representatives of NEI discussed when the Interim Staff Guidance might become final.

Representatives of the NRC indicated that there was no specific schedule for issuance of final guidance at this time but stated that the intention is to finalize the guidance in the form of the updated Standard Review Plan or Regulatory Guide in 2008 or 2009 time frame

Representatives of the NEI discussed that NRC should consider a rule change to 10 CFR 50.55a(h) to reference the current version of Institute of Electrical and Electronics Engineers, Inc. (IEEE) Std 603, "IEEE Standard Criteria for Safety Systems for Nuclear Power Generating Stations," which is an incorporated reference in 10 CFR 50.55a(h). The version referenced in 10 CFR 50.55a(h) is the 1991 version. The current version is the 1998 version.

Representatives of the NRC presented a progress report on TWG #2 (Presentation 1, ADAMS Accession No ML073190128). The presentation included discussions on comments on the common cause failure (CCF) white paper; diversity strategy development; and Advisory Committee on Reactor Safeguards (ACRS) recommendations.

Representatives of the NEI presented information on Defense-In-Depth and Diversity Issues (Presentation 2, ADAMS Accession No. ML073190141) including Adequate Diversity; Manual Operator Actions; Branch Technical Position (BTP) 19, Position 4; Effects of CCF; CCF Applicability; Echelons of Defense; and Single Failure.

The delivery date for the paper on Adequate Diversity was discussed which is estimated to be late November, 2007. Representatives of the NEI indicated that draft industry guidance on diversity/defensive measures approach would take approximately 3 months after they receive the Adequate Diversity paper.

The delivery date for the CCF white paper was discussed which is estimated to be mid to late 2008.

Representatives of the NEI indicated that they are still working on a Pilot Plant agreement with a NRC licensee.

Representatives of the NRC stated that if NEI has comments or feedback on any Defense-In-Depth and Diversity issues that they should be submitted through the NRC's DI&C public web site/e-mail address.
