To Whom It May Concern::

Pursuant to the Freedom of Information Act, 5 U.S.C. Section 552 *et seq* ("FOIA"), I hereby request that I be allowed immediate access to, or in the alternative, copies of a list of all inattentive security officer findings for 2007 nationwide.

I am a reporter for Bloomberg News, an accredited and recognized newsgathering organization, and request the Records in order to inform the public about matters of public concern.

Because the Nuclear Regulatory Commission is a governmental entity within the definitions set forth by Section 552(f) of the FOIA, please state in writing within 20 (twenty) days of this letter pursuant to Section 552(a)(6)(A)(i). If you decide to withhold any Record(s) or redact any information from the Record(s), please state the legal basis you assert for so deciding, pursuant to Section 552(b).

If you choose to make the Records available but your estimate is that actual costs will exceed this amount, please contact me so that I may make the appropriate arrangements for payment. Please contact me if I may expedite your office's satisfaction of its obligations under the FOIA.
