SUBJECT: SUMMARY OF JUNE 12, 2008, CATEGORY 2 PUBLIC
MEETING WITH THE NUCLEAR ENERGY INSTITUTE
TO DISCUSS HEALTH PHYSICS ISSUES FOR NEW
REACTORS

On June 12, 2008, the Nuclear Regulatory Commission (NRC) staff met with members of the Nuclear Energy Institute (NEI) to discuss new reactor health physics issues. Enclosure 1 lists the meeting attendees.

NRC issued a public meeting notice on May 29, 2008 and posted it on the NRC's external (public) web page (Agencywide Document Access Management System (ADAMS) Accession No. ML081490470). The notice included the meeting agenda, which was also available as a handout at the meeting.

The meetings discussions included:

- General Combined License (COL)/Design Certification (DC) Application Status and Lessons Learned
- NEI Radiation Protection Program Templates Status
- GALE, LADRAP and GASPAR Computer Codes Updates
- Regulatory Guide 4.21 Status

NRC started with a discussion of the status of the radiation protection review of the current COL and DC applications.

Next, NRC and NEI representatives discussed the status of the four Radiation Protection Program templates being developed by NEI to support the COL applications. NRC handed out copies of comments for NEI template 07-09, Offsite Dose Calculation Manual Program Description (ML081750299). NRC stated there are no further questions at this time for NEI template 07-10, Process Control Program. NEI representative stated the updates for NEI 07-03, Radiation Protection Program Description, and NEI 07-08, ensuring that Occupational Radiation Exposures are as Low as Reasonably Achievable template, will be provided to the NRC in the upcoming week.

NRC mentioned updates to the GALE, LADTAP, and GASPAR computer codes are still underway. NEI representative stated they continue to discuss methods to support these health physics computer code updates.

Finally, the NRC noted that the Regulatory Guide 4.21, Minimization of Contamination and Radioactive Waste Generation: Life-Cycle Planning (ML080500187) has been published for use. The Regulatory Guide is publically available and will be located on the public website soon. The NRC stated that Requests for Additional Information to support the regulatory guide are currently being sent out to all DC and reference COL applications.

NEI representative stated their goal of creating a template for the operational parts of the regulatory guide. The NEI representative stressed that the goal of the template is to deal specifically with operational programs and not design issues.
