PURPOSE: This meeting was held at the request of Strata Energy, Inc. (Strata) for the purpose of submitting hard copies of its application for the Ross In Situ Recovery (ISR) Project in Crook County, Wyoming.

BACKGROUND:

Strata submitted a Letter of Intent to the U.S. Nuclear Regulatory Commission staff on October 5, 2009. This letter notified the staff that it intended to submit an application to operate an ISR at the Ross site in Crook County, Wyoming, in December 2010.

DISCUSSION:

The meeting started with introductions. Strata then hand-delivered hard copies of its application for the Ross ISR project to the staff. Strata noted that an electronic submittal was made during the week of December 27, 2010; however, this submittal had not arrived at the time of this meeting. The staff and Strata then discussed general information about the application, the safety review process, and the environmental review process. The staff stated that a single environmental review document that serves both the NRC's and the Bureau of Land Management's (BLM) needs would be best, and that the NRC staff would start coordinating with BLM on that issue. The staff also stated that it would start the Section 106 coordination process soon to avoid potential future delays.

Update: The electronic submittal was received on January 6, 2011, which is the official submittal date for this application. The application has been entered into the NRC's Agencywide Document Access and Management System (ADAMS) and may be found at Accession No. ML110120063.
