Luminant Generation Company LLC (Luminant) submits herein Update Tracking Report (UTR) Revision 8 for the Final Safety Analysis Report, which is Part 2 of the Combined License Application (COLA) for Comanche Peak Nuclear Power Plant Units 3 and 4. The UTR reflects changes to maintain consistency with US-APWR Design Control Document Revision 3, designates conceptual design information, and provides information required by COL Information Items. The tracking report revision list provides a summary of and a reason for each change, and addresses any differences in page numbers between COLA Revision 1 and the UTR.

Attachment 1 is the public version of the UTR, but Attachment 2 contains Sensitive Unclassified Non-Safeguards Information and should be withheld from public disclosure. Both attachments are provided to the NRC on a single CD. This letter is unclassified upon removal of Attachment 2.


