I am requesting a fee waiver because the information I am requesting will contribute significantly to the public's understanding of the operations of the government and/or is primarily in the public interest.

As you are aware, the FOIA requires you to release documents in portions in the event they contain exempt material. For any documents or portions that you deny due to specific FOIA exemption, please provide an index itemizing and describing the documents or portions of documents withheld.

It is understood that we are entitled to make this request under the Freedom of Information Act, and if your agency response is not satisfactory, or if we do not hear a response in the 20 days allowed by law, we are prepared to make an administrative appeal. If my request is denied or not fully granted, we are also prepared to make an administrative appeal. In future correspondences please indicate to me the name of the official to whom such an appeal should be addressed. We also know that by law, your agency is required to tell me why my request is denied or not fully granted.
