- 3. Any report, advisory, or technical analysis of the event outlined in Information Notice No. 83-83 [1] that took place at Grand Gulf on July 25, 1983. Specifically the exact vendor, hardware, and/or software that was impacted, only described as "cooling loop B", as relates to "an RHR equipment area high temperature trip".
- 4. Any report, advisory, or technical analysis of the event surrounding the incident at the Davis-Besse nuclear power plant around March, 2011. Specifically the exact vendor, hardware, and/or software that was impacted, only described in the media [2] as an "emergency water cooling system" that was a result of a "a walkie talkie".
