Dear Mr. Jones:

By letter dated September 16, 2014, Hydro Resources Inc. (HRI), a subsidiary of Uranium Resources, Inc. (URI), provided the U.S. Nuclear Regulatory Commission (NRC) staff with an updated notice of ongoing activities related to its NRC license renewal request for Material License SUA-1580. The September 16, 2014, letter can be found in NRC's Agencywide Documents Access and Management System (ADAMS) at Accession No. ML14288A458.

HRI originally requested renewal of Materials License SUA-1580 in a letter dated August 22, 2002 (Accession No. ML022460195), and subsequently supplemented its license renewal application with a submission dated March 21, 2013 (Accession No. ML130980185). In a letter dated February 5, 2014 (Accession No. ML14056A288), HRI provided notice of intent to further revise the license renewal application for SUA-1580. In that letter, HRI notified the NRC staff it was working with representatives of the Navajo Nation to consider the terms of an agreement that would result in mutual gains for both the Navajo Nation and URI and that changes to the license renewal documents were expected to result from any such agreement. HRI proposed to update the license renewal documents by June 1, 2014. Subsequent to that notification, the NRC staff stopped actively reviewing the license renewal documents pending receipt of the revised license renewal documents.

In its September 16, 2014, letter, HRI provided a short summary of activities related to its interactions with the Navajo Nation. HRI reaffirmed that additional changes to the license renewal application are expected to result from these interactions and that additional time is required for its work with the Navajo Nation Council. HRI stated, "HRI believes that it is vital to continue its work with the Navajo Nation Council because we desired to seek consensus on various aspects of our project before action is taken by the NRC on the license renewal."
