**Commissioner Svinicki's Comments on SECY-16-0070
Integrated Strategy to Modernize the NRC's Digital Instrumentation and Control
Regulatory Infrastructure**

I approve the staff's planned set of activities, as described in the Integrated Action Plan (Enclosure 1 to SECY-16-0070), that are being undertaken with the intent of achieving "a state in which the nuclear power industry can obtain regulatory approval to use digital technology that provides for adequate safety and security through processes that are efficient, minimize uncertainty, and can be consistently applied across different technologies." As the staff acknowledges, the Integrated Action Plan is intended to be a "living document" subject to staff revision. Consequently, Commission approval of the plan itself is neither necessary nor appropriate. Rather, I approve the activities proposed by the staff as Modernization Plans 1 through 4, as the appropriate priorities for this effort. When combined with the issues outlined in Appendix A, "Additional Regulatory Infrastructure Modernization Topics (May 2016)," the activities encompassed by the plan are both fully consistent with the Commission-directed policy attributes contained in SRM-SECY-15-0106 and, as a result of the extensive stakeholder engagement on these topics conducted by the staff, reflect a comprehensive understanding of the work to be done to achieve the overall vision.

The establishment of the executive steering committee will help to guide the staff's progress in this work, however, the attention of the Commission itself will also advance these efforts. In light of the staff's desire to maintain the Integrated Action Plan as a "living document" subject to unilateral change by the staff, some mechanism for Commission oversight is needed. To meet this need, one year after the issuance of the staff requirements memorandum for SECY-16-0070 and annually thereafter, the staff should provide a paper to the Commission reporting on the status of the work on and planned future activities for Modernization Plans 1 through 4, and any future progeny. The paper should also contain the staff's assessment of agency progress against the staff's long-term modernization goal of "a simpler, streamlined, and agile [instrumentation and control] I&C regulatory infrastructure that will effectively address large scale digital I&C facility upgrades and I&C designs for new and advanced reactors, as well as medical radioisotope production and irradiation facilities." For the first two years of staff activity under the plan, semi-annual Commissioner Assistants briefs, similar to those offered on other complex generic issues, should be conducted by the staff.

I approve the staff's proposal to address any shortfalls in the FY 2017 budget for these activities through the agency add/shed process. Resources for these activities in FY 2018 have been addressed in Commission direction on the FY 2018 budget. In resolving these complex issues, the staff should seek frequent public and stakeholder interactions. In order to facilitate timely internal NRC alignment, matters should be elevated to the steering committee without undue delay. As the staff completes activities in accordance with the plan, any policy issues identified should be presented to the Commission promptly for resolution.

I approve the staff's detailed action plan to improve NRC's regulatory process for digital instrumentation and control systems, subject to two additions. Because the NRC staff is engaged with stakeholders on the development of the 2018 version of the Institute of Electrical and Electronics Engineers (IEEE) Standard 603, the staff has not included adoption of the 2009 standard in its action plan. I think that's a reasonable approach. In order to facilitate the timely adoption of the 2018 standard, the staff should provide the Commission with a rulemaking plan to adopt the new standard, subject to any licensing and technical conditions the staff may propose, within 30 days of the issuance of this revised IEEE Standard. In addition, the staff should brief the Commission Technical Assistants every six months on the status of implementation of the action plan.
