In this paper, the NRC staff recommends using most of the remaining \$1.27 million in previously-appropriated Nuclear Waste Fund (NWF) dollars for additional knowledge management activities that "would provide detail on the new information and insights that the staff gained in completing" the Safety Evaluation Report for the Yucca Mountain geologic repository application. The staff estimates that this knowledge management effort would cost \$700,000 and be completed during fiscal year 2017. According to the staff, "Capturing this information now would position the agency well in the event that the Yucca Mountain repository adjudication is resumed or for potential NRC licensing of another geologic repository for high-level waste." The staff proposes to keep the expected remaining balance of \$570,000 in reserve for any unanticipated expenditures. Although the \$1.27 million could be used to restart a rulemaking related to fitness-for-duty requirements or security and material control and accounting measures, the staff does not recommend this option because "it is not clear that [such a rulemaking] can be completed with the remaining NFW resources." I think the staff's plan for using the remaining previously-appropriated NWF funds is reasonable and, therefore, approve the staff's recommendation.
