Gentlemen:

Your letter of April 24, 1987, transmitted Issue 2, Revision 0, to the Pilgrim Station Security Plan under the provisions of 10 CFR 50.54(p). Issue 2, which is a total revision of the security plan previously approved by the NRC for the Pilgrim Station, also included Boston Edison Company's commitments to comply with the Miscellaneous Amendments to 10 CFR 73.55, codified by NRC in August, 1986. Those portions of Issue 2 that address the Miscellaneous Amendments are being reviewed by our Headquarters' staff who will respond to you directly regarding their acceptability.

We have reviewed the remainder of this plan revision and have determined that portions of the revision are consistent with the provisions of 10 CFR 50.54(p), and are considered acceptable. However, certain other portions are not considered acceptable for the reasons stated in the enclosure to this letter. For the portions considered not acceptable, you are to revert to previously approved plan wording/modify accordingly and submit corrected page revisions to this office within 30 days of receipt of this letter. If you wish to pursue changing your plan with respect to the portions considered not acceptable under 10 CFR 50.54(p), you should submit the changes under the provisions of 10 CFR 50.90.

The enclosures to your letter and the enclosure to this letter are being withheld from public disclosure, since they contain Safeguards Information and must be protected in accordance with 10 CFR 73.21.
