Chairman Nils Diaz,

The National Enrichment Facility would have a great impact on helping to diversify our economy. This would happen thru employment opportunities for our citizens, an increased tax base for Lea County and other business entities in support of LES operation. The construction project will be one of the largest single enterprises in this region. The annual employment package, corporate gifts and operational expenses would have a tremendous impact on Lea County.

Most communities would have large concerns about a uranium enrichment facility. I know our community and Zia Natural Gas Company would welcome Louisiana Energy Services to southeastern New Mexico.

National Enrichment Facility's gas centrifuge enrichment facility will benefit the United State by meeting the requirements for enriched uranium. Since nuclear generated electricity has proven to be a practical, dependable and irreplaceable energy source the citizens of the US should support them. I trust the NRC and other federal agencies will investigate the proposed NEF project and find that LES and Urenco Ltd can operate the facility safely.
