

**Commissioner Svinicki's Comments on SECY-11-0105  
Proposed Minor Revision to Management Directive 5.12,  
"International Nuclear Event Scale Participation"**

The International Nuclear Event Scale (INES) exists to facilitate understanding of nuclear events by using a numerical rating to explain the significance of nuclear or radiological events. Subsequent to the events at Fukushima-Daiichi, the International Atomic Energy Agency, the INES Advisory Committee, and the international nuclear community are engaged in efforts to evaluate the usefulness of the INES.

As established by Commission policy in 2002, the NRC submits reports for U.S. events rated Level 2 (incident) or higher. The staff now proposes to submit event reports for certain events rated Level 1 (anomalies) and Below Scale/Level 0 (no safety significance). I approve this request.

This proposal introduces a potential discontinuity, however, between the reporting of the United States and that of other nations. No clear definition is provided by the staff for those events at Below Scale/Level 0 or Level 1 that the staff proposes to submit to INES. Examples provided by the staff of events that it would have submitted in recent years, if this change had been in effect, are of events about which information was already available on the NRC's public website at the time "international interest" was generated. If the staff proposes to submit an event to INES that is Level 1 or Below Scale / Level 0, the staff should inform the Commission in writing at least three business days in advance. If the Commission takes no action in that time, the Level 1 or Below Scale / Level 0 event may be submitted to INES.

Regardless of whether an event is submitted to INES, the NRC should continue to be as open and transparent as it has been, by making information about U.S. events promptly, publicly available through the NRC's normal practices.
