As you are aware, the United States Government is obligated under the "Protocol Additional to the Agreement between the United States and the International Atomic Energy Agency for the Application of Safeguards in the United States" (the Additional Protocol) to provide to the International Atomic Energy Agency (IAEA) an annual national declaration. This declaration will be developed from information received from the Departments of Commerce (DOC), Energy and Defense, and the Nuclear Regulatory Commission (NRC). Declaration number 13 is a place holder for Turkey Point – 4, which is a power reactor that has yet to submit their information. It is my understanding that they will be submitting their information in the next 15-30 days.

No vote is required for declaration 17 since the U.S. has nothing to declare.

Declaration 15, lines 1-21 are those mines that have been abandoned since the U.S. signed the AP 6/12/98. The information was obtained from MSHA as it was reported to them by the mine holders.
