Canadian Nuclear Safety Division Meeting

On October 24, 2001, members of the Operator Licensing and Human Performance section met with Andre Vachon and Dave Shaw, members of the Canadian Nuclear Safety Commission, Personnel Qualification Assessment Division. Topics of discussion included a review of NRC training inspections, and discussions of NRC involvement in the training program accreditation process and INPO-managed accreditation team visits.

Public Meeting with NEI and Industry Representatives on Radiation Safety Cornerstones

On October 30, 2001, members of the Emergency Preparedness and Health Physics Section, NRR, conducted a public meeting with the NEI radiation safety taskforce and other stakeholders. The NEI taskforce requested the meeting to discuss their draft comments concerning proposed changes to the radiation safety cornerstones of the reactor oversight process (ROP) resulting from the March 2001 implementation lessons learned workshop. The lessons learned ROP changes are currently out for NRC regional staff comments, and are scheduled to be in place by January 2002. All comments received will be considered before implementation.

Reactor Oversight Process

The Inspection Program Branch (IIPB) conducted a public meeting on October 31, 2001, with industry's working group on the ROP for the finalization of the draft Revision 2 of NEI 99-02, "Regulatory Assessment Performance Indicator Guideline." During this meeting, the working group discussed: changes to the unplanned scram replacement performance indicator (PI); clarifying notes for unplanned scrams with loss of normal heat removal PI; frequently asked questions; safety system unavailability (SSU) PIs; guidance for a pilot program to test the long-term changes to the SSU indicators; and other changes to NEI 99-02.

Nuclear Energy Institute (NEI) License Renewal Forum

NEI held its annual license renewal forum in Charleston, South Carolina, from October 31 through November 2, 2001. The purpose of this forum was to discuss various aspects of license renewal issues such as project management, effective renewal applications, communication and outreach programs, technical issues, environmental impacts, and inspection lessons. Over 125 executives and managers from utilities, industry organizations, and international representatives participated in the forum. NEI also invited several NRC staff who are involved in license renewal issues to speak and participate.

Public Meeting to Solicit Stakeholder Input on the Use of Risk Information in the Nuclear Materials and Waste Regulatory Process

On October 25, 2001, the Risk Task Group (RTG) held a public meeting in the Two White Flint auditorium to: (1) present insights, from case studies, about finalization of the screening considerations, regulatory process improvements, and development of safety goals for use of risk information in the nuclear materials and waste regulatory process; (2) discuss plans for moving forward with risk-informed activities in the materials and waste arenas; and (3) solicit comments and recommendations on the development of safety goals and the planned activities. More than 30 people representing a cross-section of stakeholders attended the meeting, including representatives from industry, the Federal government, non-governmental organizations, and NRC.

Meeting on International Regulations for Transitional Arrangements for Transport Packages

On October 29 through November 2, 2001, staff from the Spent Fuel Project Office participated in a meeting at the headquarters of the International Atomic Energy Agency (IAEA). The meeting concerned the transitional arrangement being developed for the 2003 edition of the IAEA transportation regulations. The transitional arrangements, or "grandfathering" provisions, allow the continued use of packages certified to previous editions of the regulations. The meeting was held to evaluate member-state comments on the proposed transitional arrangements. The nine participants represented six countries and an industry group. The participants developed specific options and recommendations for further consideration in the IAEA revision development process.

Observation of the Bechtel SAIC Company, LLC, Audit of Lambda Research, Inc.

On October 31 through November 1, 2001, Division of Waste Management staff observed the Bechtel SAIC Company (BSC), LLC, quality assurance (QA) supplier audit of Lambda Research, Inc. BSC is the Department of Energy's (DOE's) maintenance and operating contractor for the Yucca Mountain project, and Lambda Research, Inc., is a supplier for BSC. The BSC/DOE audit team evaluated the effectiveness of Lambda's QA program implementation.

Status of the Revised 10 CFR Part 35

The appropriation bill for the NRC (H.R. 2231), containing the revised 10 CFR Part 35, cleared the House and Senate on November 1, 2001, and has been signed by the President (public law 107-66). The bill prohibited NRC spending on implementation or enforcement of those portions of the revised Part 35 concerning diagnostic nuclear medicine (except training and experience requirements), and directed the Commission to report to Congress by January 31, 2002, why regulatory burden from diagnostic nuclear medicine could not be further reduced without adversely affecting public health and safety.

NASA Human Error Modeling Workshop

On October 18-19, 2001, representatives from RES attended the 2001 Human Error Modeling (HEM) Workshop at the NASA Ames Research Center. The workshop serves as the annual summary of HEM activities in NASA's System Wide Accident Prevention program. From the introduction to the workshop, "[t]he ultimate objective of HEM is to promote the development of computational models with predictive capabilities that will enable designers to identify likely vulnerabilities in future human/system aviation operations."

Overall, the workshop discussions addressed some of the "first principles" approaches to human modeling. These approaches may have value in coordination with "top-down" human reliability analyses, particularly for analysis of low-likelihood events where operational data is sparse or non-existent. Both during and since the workshop, contact has been made with NASA staff and contractors involved in the HEM program to explore the possibilities for collaborative research concerning human performance and human reliability.

NRC Staff Participation at the American Institute of Hydrology (AIH) Annual Meeting

On October 16, staff presented an invited paper on "Future Trends in Hydrogeologic Analyses at the U.S. NRC" at the AIH annual meeting. The AIH meeting, which commemorated its 20th anniversary, focused on "Hydrologic Science: Challenges for the 21st Century." The paper was authored by RES and NMSS staff, and provided insights into current and future trends in NRC staff technical assessments involving hydrogeologic analyses using a risk-informed, performance-based approach. The paper was submitted for publication in the AIH journal, Hydrological Science and Technology. The meeting attendees included: U.S. Geological Survey management and staff, Nuclear Waste Technical Review Board, EPA scientists, university professors and students, DOE national laboratory scientists, DOE consultants, State and local government representatives, and industry vendors and consultants.

Nine Mile Point, Units 1 and 2

As of 12:01 a.m., November 7, 2001, Constellation Nuclear took 100% and 82% ownership of Nine Mile Point Units 1 and 2, respectively. The ownership interests, as well as operating authority, will actually be held by an indirect Constellation subsidiary, Nine Mile Point Nuclear Station, LLC (NMP LLC).

The NRC approved such transfers by an order dated June 22, 2001, which was revised by a supplemental order dated October 30, 2001. The NRC revised the operating licenses and associated documents to reflect NMP LLC's ownership and operating authority by conforming amendments issued on November 7, 2001.
