The presence of member added inertia data from the MEMBER ADDED INERTIA command and/or the INERTIA OF JOINTS FROM LOAD command will cause any dynamic analysis to abort if the member added inertia data are applied to members having variable properties and the MEMBER ADDED INERTIA and/or INERTIA OF JOINTS FROM LOAD commands are the only inertia command(s) (INERTIA OF JOINTS LUMPED/CONSISTENT command also was not specified). Large dynamic analysis problems – eigenvalue analysis, direct integration physical analysis – may abort if the out-of-core solver is used. The out-of-core solver is automatically invoked if the number of terms in the skyline of the upper-triangular portion of the assembled global stiffness matrix exceeds 131,072. The out-of-core solver divides the upper-trianular skyline portion of the stiffness matrix into blocks that are stored into and managed from temporary disk files on your hard drive. The default block size is 131,072 terms. The abort can occur only if the required number of blocks – number of terms in the skyline divided by the block size – exceeds 1000. Below is an example of GTStrudl output from the DYNAMIC ANALYSIS EIGENVALUE command, where the portion of the output labeled "GT/LANCZOS SOLUTION DATA" indicates that the out-of-core solver was invoked using 183 blocks (the default block size = 131,072 terms). This output is produced because the PRINT MAX option is given in the EIGENVALUE PARAMETERS command block.

The work-around for this problem is to directly specify the block size such that the out-of-core solver uses less than 1000 blocks. This is accomplished in the EIGENVALUE PARAMETERS command by issuing the BLOCKSIZE option as follows:

DESCRIPTION:

The NONLINEAR ANALYSIS command may abort when the structure contains elastic member end connections and more than one independent loading condition is active for the analysis. A work-around is to perform a separate nonlinear analysis for each loading condition. For example, the following NONLINEAR ANALYSIS command may abort under the conditions described above:

LOAD LIST 1 2 3 NONLINEAR ANALYSIS

The following equivalent sequence of commands will avoid the abort:

DESCRIPTION:

The PRINT REINFORCEMENT command for columns with a circular longitudinal steel arrangement designed with BSI codes (CP110 and BS8110) reports the diameter of the circular steel cage as too large, usually larger than the diameter of the concrete. The design of the column is not affected by this problem, and the output from the PROPORTION command is correct. Only the diameter reported by output commands, such as PRINT REINFORCEMENT, issued after the design is incorrect.

Columns with rectangular or square longitudinal steel arrangements are not affected.

An abort in PROPORTIONING reinforced concrete columns designed with the ACI codes can occur during the capacity check phase. No design output is produced and GTSTRUDL stops executing. Incorrect results will NOT be reported.

Since the capacity check is an iterative, heuristic algorithm, an *a priori* description of the type of column (size, loadings, etc.) cannot be provided for those columns that will experience this abort, but this abort is extremely rare and will be apparent.





DESCRIPTION:

The horizontal frequency/period axis of response spectrum x-y plots created from the graphical user interface is incorrect when the active angular unit is CYCLES. The menu selection to create these plots is illustrated below:



The figure below illustrates an erroneous response spectrum plot:



The largest frequency value in the data used to create this plot was 49 Hz. The frequency scale is in error by a factor of $4\pi^2$, which is very noticeable.

The work-around to produce correct plots is to set the active angular unit to RADIANS or DEGREES prior to creating the plot.

Note that Georgia Tech CASE Center policy governing GPRF notification does not generally include the graphical user interface; however, this particular error was deemed sufficiently important to warrant this notification.
