**REQUEST FOR INFORMATION ABOUT USE OF INSPECTION MANUAL CHAPTER 2800,  
MATERIALS INSPECTION PROGRAM, AND THE ROUTINE INSPECTION PROCEDURES  
(STP-04- 040)**

The National Materials Program Pilot Project Five requests information from the Agreement States about their use of the revised materials inspection program described in the NRC Inspection Manual Chapter (IMC) 2800 and the 12 associated routine inspection procedures. Pilot Project Five tested the implementation of the revised materials inspection program in the Non-Agreement States and would like to understand how the Agreement States are using the revised NRC IMC 2800 and the associated inspection procedures. The information collected will be analyzed and included in the final report for Pilot Project Five which will be provided to the Commission later this year.
