SUBJECT: SUPPLEMENT - SHUTDOWN EXPECTED TO BE GREATER THAN 72

HOURS TO REPAIR AN INOPERABLE DRYWELL TO SUPPRESSION

CHAMBER VACUUM BREAKER

The NRC has completed its initial review of the causes and corrective actions for an open drywell to suppression chamber vacuum breaker at Hope Creek Nuclear Generating Station and has concluded that the plant is safe for restart.

Following the plant shutdown, PSEG entered the suppression chamber and inspected all drywell to suppression chamber vacuum breakers. PSEG identified a misalignment on the 'B' vacuum breaker magnetic closure assembly due to a loose locknut. PSEG also noted a similar condition on the 'C' vacuum breaker; however, the 'C' vacuum breaker had remained closed. PSEG performed an analysis to determine the direct cause of this degraded condition and has implemented immediate corrective actions. In addition, PSEG has begun a root cause investigation of this condition.

The NRC review was completed by the resident inspectors, who performed independent inspections of the conditions noted and monitored PSEG's investigation and repair efforts. The results of the NRC inspection activities will be documented in the routine resident inspector reports.

The information presented herein has been discussed with PSEG and is current as of 9:00 a.m. on September 1, 2005.
