# TECHNICAL CONFERENCE FORUM: OPPORTUNITY TO COMMENT ON PROPOSED RULE: SECURE TRANSPORT OF NUCLEAR MATERIAL (STP- 06-018)

## Purpose:

To request Agreement State comment on a draft <u>Federal Register</u> notice amending 10 CFR Parts 30, 70, 73, and 110 to implement requirements for secure transfer of nuclear materials as mandated by the Energy Policy Act of 2005 (Section 656). Comments are requested by **March 15, 2006.**\*

## Discussion:

The U. S. Nuclear Regulatory Commission (NRC) staff has prepared a draft <u>Federal Register</u> notice amending 10 CFR Parts 30, 70, 73, and 110 to implement requirements for secure transfer of nuclear materials as mandated by the Energy Policy Act of 2005 (Section 656), which was signed into law on August 8, 2005. The law requires that NRC issue regulations by August 7, 2006. The proposed amendment would require a security background check of each individual receiving or accompanying the transfer of nuclear material in the United States by any party pursuant to an import or export license. Specific requirements for the nature of the security background check are contained in the proposed amendment, including exceptions for certain types of nuclear material and certain classes of individuals.

The draft Federal Register notice is being made available for your review and comment in parallel with NRC interoffice review, before providing it to the Commission. Agreement State comments will be summarized and included in the SECY paper when the proposed rule is provided to the Commission in late March. Please note that this is predecisional information provided for your review, and is available only at the Agreement State area of the NRC's Technical Conference Forum: <a href="http://techconf.llnl.gov/cgi-states/topics">http://techconf.llnl.gov/cgi-states/topics</a>, and should not be made publically available.
