In response to NRC Generic Letter 2004-02 (Reference 1), certain licensees submitted responses that referenced one or more industry technical reports documenting jet impingement testing performed to reduce debris generation. Subsequent to reviewing these documents the NRC staff developed a number of questions (RAI's) regarding jet impingement testing documented in those industry documents. The Pressurized Water Reactor Owners Group (PWROG), on behalf of affected licensees, has requested that the NRC staff's questions on these reports be resolved generically through the PWROG to the extent feasible. In support of this request, the NRC forwarded the questions to the PWROG (see Reference 2) in January of 2010. The NRC staff originally transmitted twelve (12) draft RAIs to the PWROG regarding the technical reports, but later consolidated them into seven draft issues which encompass the concerns of the original twelve questions (see enclosures of Reference 2).

DO48 NRP The purpose of this letter is to transmit PWROG's responses to the NRC's consolidated issues (as were received via Reference 2). The non-proprietary PWROG responses are provided in Enclosure 1.
