AUGUST 31, 2011 PUBLIC MEETING TO SOLICIT COMMENTS ON NEAR-TERM TASK  
FORCE REPORT RECOMMENDATIONS (FSME-11-083)

**Purpose:** To solicit public comments on actions the U.S. Nuclear Regulatory Commission (NRC) staff proposes to take to address near-term Task Force recommendations for enhancing reactor safety, as identified in the July 12, 2011, report, "Recommendations for Enhancing Reactor Safety in the 21<sup>st</sup> Century."

**Background:** The NRC Near-Term Task Force was established to conduct a methodical and systematic review of NRC processes and regulations in response to the March 11, 2011, Japanese earthquake and tsunami. NRC senior managers, members of the NRC staff, and external stakeholders will meet in a facilitated meeting to discuss six of the recommendations in the Task Force report.

**Discussion:** The public meeting will take place August 31, from 1:00 – 4:00 p.m. Eastern time, in the Commission's Hearing Room at NRC Headquarters, located at 11555 Rockville Pike, Rockville, Maryland. The official meeting notice with agenda can be viewed at:
