On March 12, 2012, the NRC issued Reference 1 to all power reactor licensees. Enclosure 3 of Reference 1 contains specific requested actions, requested information, and required responses associated with Recommendation 2.3 for seismic walkdowns. Entergy Operations, Inc. (Entergy) confirmed in Reference 2 that it would use the seismic walkdown procedure (EPRI Report 1025286, *Seismic Walkdown Guidance: For Resolution of Fukushima Near-Term Task Force Recommendation 2.3: Seismic*) as endorsed by the NRC as the basis to conduct the walkdowns and develop the needed information at Arkansas Nuclear One, Unit-2 (ANO-2).

Pursuant to Required Response 2 of Reference 1, Enclosure 3, Entergy is providing the Seismic Walkdown Report for ANO-2 in Attachment 1.
