STATEMENT AND RULEMAKING

On Wednesday, March 20, 2013, members of the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 3 public teleconference at the NRC headquarters in Rockville, Maryland. The purpose of the teleconference was to maintain an open line of communication with the public by providing a status update on NRC staff's progress in developing the Waste Confidence draft generic environmental impact statement (GEIS) and Rule. Participants had an opportunity to ask questions about the NRC's process and activities.

The meeting began at 1:30 p.m. (Eastern Time) ET and concluded at 2:30 p.m. ET. The NRC staff began the meeting with an overview of the NRC mission, a review of the timeline for Directorate activities, and a brief synopsis of the March 14, 2013 Waste Confidence session at the NRC Regulatory Information Conference. The NRC presentation continued with a discussion of the March 5, 2013, Scoping Summary Report, including details about the purpose and organization of the Report, a review of key issues, and methods for obtaining the Report. The NRC also noted that details regarding regional public meetings for commenting on the draft GEIS will be shared during the next status update teleconference on April 17, 2013. The staff then opened the teleconference for questions.

There were 90 participants in the teleconference representing members of the public, tribal and state governments, industry, public advocacy and environmental interest groups, and the NRC and its contractors. A list of meeting attendees is attached.
