SUBJECT: SUMMARY OF PUBLIC TELECONFERENCE TO DISCUSS STATUS

OF WASTE CONFIDENCE GENERIC ENVIRONMENTAL IMPACT

STATEMENT AND RULEMAKING

On Wednesday, April 17, 2013, members of the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 3 public teleconference at the NRC headquarters in Rockville, Maryland. The purpose of the teleconference was to maintain an open line of communication with the public by providing a status update on NRC staff's progress in developing the Waste Confidence draft generic environmental impact statement (GEIS) and Rule. Participants had an opportunity to ask questions and comment about the NRC's process and activities.

The meeting began at 1:30 p.m. and concluded at 2:30 p.m. EDT and was assisted by an operator who captured the name and organization of each participant, and moderated the individual phone lines. The NRC staff began the meeting with an overview of the NRC mission, a review of the timeline for Directorate activities, and an update regarding the availability of the speakers' presentations from the March 14, 2013, Waste Confidence session at the NRC Regulatory Information Conference (RIC) on the RIC website.

The NRC presentation continued with a discussion of the locations for 10 public meetings during the comment period for the Waste Confidence draft GEIS and Rule. These 10 public meetings will be held in the vicinity of the following areas: two meetings in the Washington, D.C. metropolitan area; one in the Boston, Massachusetts metropolitan area; one in the New York City metropolitan area; one in Denver, Colorado; one in Minneapolis, Minnesota; one near San Luis Obispo, California; one near San Clemente, California; one in Toledo, Ohio; and one in Charlotte, North Carolina.
