STATEMENT AND RULEMAKING

On Wednesday, May 29, 2013, members of the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 3 public teleconference at the NRC headquarters in Rockville, Maryland. The purpose of the teleconference was to maintain an open line of communication with the public by providing a status update on NRC staff's progress in developing the Waste Confidence draft Generic Environmental Impact Statement (GEIS) and proposed rule. Participants had an opportunity to ask questions and make comments about the NRC's process and activities.

The meeting began at 1:30 p.m. and concluded at approximately 2:30 p.m. EDT. The NRC staff began the meeting with an overview of the mission of the Waste Confidence Directorate, an update regarding the availability of additional information from the March 14, 2013, Waste Confidence session at the NRC Regulatory Information Conference (RIC), and a brief notification of the next opportunity to comment on the draft GEIS and proposed rule.

The NRC presentation continued with a discussion of the availability of the Commission Review Draft documents expected at the end of June. These documents, which are being sent to the Commission for review, include the Commission Paper (SECY Paper), the preliminary Federal Register Notice regarding the proposed rule, and the preliminary draft GEIS. These documents will be made publicly available in the NRC's Agencywide Document Access and Management System (ADAMS); however, they are subject to change by the Commission and are not for public comment. The official 75-day public comment period on the Commission-approved draft GEIS and proposed rule will begin when they are published in early fall.

The NRC presentation continued with a reminder about the upcoming draft GEIS public meetings and discussion of the process used to determine meeting locations. The first and last
