SUBJECT: SUMMARY OF PUBLIC TELECONFERENCE TO DISCUSS STATUS

OF WASTE CONFIDENCE GENERIC ENVIRONMENTAL IMPACT

STATEMENT AND RULEMAKING

On Wednesday, June 19, 2013, members of the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 3 public teleconference at the NRC headquarters in Rockville, Maryland. The purpose of the teleconference was to maintain an open line of communication with the public by providing a status update on NRC staff's progress in developing the Waste Confidence draft Generic Environmental Impact Statement (GEIS) and proposed rule. Participants had an opportunity to ask questions about the NRC's process and activities.

The meeting began at 1:30 p.m. and concluded at approximately 2:30 p.m. EDT. The NRC staff began the meeting with a message of appreciation to callers for their involvement and input, an overview of the mission of the Waste Confidence Directorate to develop a GEIS and revised rule, notification that the Commission Review Draft documents would be publicly available on or about June 24, 2013, and details about the official public comment period beginning when the *Federal Register* notices for the draft GEIS and proposed rule are published in late summer or early fall.

The NRC presentation continued with a review of the format and structure of the draft GEIS that was sent by the NRC staff to the Commission for review, including identification of the ten chapters and eight appendices of the document. NRC staff then noted that the revised Waste Confidence rulemaking package is structured differently from past versions to reflect the conclusions contained in the Waste Confidence GEIS, and that the GEIS forms the regulatory basis for the revised Waste Confidence rule. Staff explained that the revised Waste Confidence rulemaking package has been structured in accordance with the NRC's well-established rulemaking process, and includes a Commission (SECY) paper, a *Federal Register* notice for Commission review containing a Statement of Considerations and proposed Waste Confidence rule, and the draft GEIS for Commission review.

On June 7, 2013 these documents were sent to the Commission for review, and in accordance with normal Commission procedures, were made publicly available in the NRC's Agencywide Document Access and Management System (ADAMS) on June 24, 2013. The Commission Review Draft documents are subject to change by Commission direction and are not for public comment at this time. The Commission Review Draft documents can be accessed from the Waste Confidence website, http://www.nrc.gov/waste/spent-fuel-storage/wcd.html, and notification of their availability was sent to all who are on the WCOutreach@nrc.gov e-mail distribution list. Web links to references cited in the documents are included on the Waste Confidence website at http://www.nrc.gov/waste/spent-fuel-storage/wcd/rule-references/.

The official 75-day public comment period on the Commission-approved draft GEIS and proposed rule will begin when the documents are published and noticed in the *Federal Register* in late summer or early fall. The Waste Confidence Directorate will communicate information regarding availability of documents, how to submit comments on the draft GEIS and proposed rule, and dates for the comment period via *Federal Register* notice, teleconference, Waste Confidence website, e-mails from wcc.upw.nc.gov, press releases, and other media. Parties interested in news and updates regarding Waste Confidence activities can send an email to wcc.upw.nc.gov to receive all the latest information.

There were 103 participants in the teleconference representing members of the public, tribal and state governments, industry, public advocacy and environmental interest groups, and the NRC and its contractors. A list of meeting attendees is attached.

Concerns, questions and issues discussed during the teleconference included: types of spent fuel covered by Waste Confidence; concern about sufficient coverage of the issues identified by the court remand of the 2010 Waste Confidence Decision, and whether the NRC communicates with the court regarding these matters; the cost-benefit analysis in the draft GEIS; a request for direct links to the Commission Review Draft documents; the exact timing of the public comment period; locations and notification of the public meetings; a question about who will be reviewing and addressing comments made on the draft GEIS and proposed rule; discussion of the timeframes used in the draft GEIS analysis; information regarding the page length of the documents and volume of cited references; concerns about uranium hexafluoride; and a question regarding whether Waste Confidence impacts early site permits.
