- SUBJECT: SUMMARY OF OCTOBER PUBLIC TELECONFERENCE TO DISCUSS STATUS OF WASTE CONFIDENCE GENERIC ENVIRONMENTAL IMPACT STATEMENT AND RULEMAKING

On Wednesday, October 30, 2013, members of the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 3 public teleconference at the NRC headquarters in Rockville, Maryland. The purpose of the teleconference was to maintain an open line of communication with the public by providing a status update on NRC staff's progress in developing the Waste Confidence draft generic environmental impact statement (DGEIS) and proposed rule. Participants had an opportunity to ask questions about the NRC's process and activities.

The meeting began at 1:30 p.m. and concluded at approximately 2:20 p.m. EDT. The NRC staff began with an introduction to the meeting, and then continued with a status of the Waste Confidence proceeding. Staff reported that due to the lapse in Federal appropriations and the subsequent government shutdown, the comment period on the Waste Confidence DGEIS and proposed rule is extended to Friday, December 20, 2013. Furthermore, meetings in California, Ohio, Minnesota, and Illinois that were postponed due to the shutdown have been rescheduled. New dates for these meetings are: Oak Brook, Illinois, on Tuesday, November 12; Carlsbad, California, on Monday, November 18; San Luis Obispo, California, on Wednesday, November 20; Perrysburg, Ohio, on Monday, December 2; and Minnetonka, Minnesota, on Wednesday, December 4. Open house and meeting times remain the same—6:00 p.m. local time for open houses and 7:00 p.m. local time to begin the meetings. NRC staff also announced the addition of another public meeting on Monday, December 9. This meeting will be a facilitated teleconference to accept comments on the documents.

There were 46 participants in the teleconference, including members of the public, state and Federal governments, industry, public advocacy and environmental interest groups, and the NRC. A list of meeting attendees is attached.
