SUBJECT: SUMMARY OF NOVEMBER 20 PUBLIC MEETING IN SAN LUIS

OBISPO, CALIFORNIA, TO RECEIVE COMMENTS ON THE WASTE

CONFIDENCE DRAFT GENERIC ENVIRONMENTAL IMPACT

STATEMENT AND PROPOSED RULE

On Wednesday, November 20, 2013, members of the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 3 public meeting at the Courtyard by Marriott San Luis Obispo in San Luis Obispo, California. The purpose of the meeting was to provide an overview of the Waste Confidence draft generic environmental impact statement (DGEIS) and proposed rule, and to accept public comments on the documents. Participants also had an opportunity to ask questions about the NRC's environmental review and rulemaking process.

The NRC conducted an open house beginning at 6:00 p.m. PST where members of the public met informally with NRC staff and asked questions related to the DGEIS and proposed rule. The public meeting began at 7:00 p.m. PST and concluded at 11:15 p.m. PST. The meeting began with an introduction of NRC staff and a review of meeting ground rules, followed by a short presentation on the Waste Confidence DGEIS and proposed rule. The majority of the meeting was dedicated to receiving comments from members of the public.
