SUBJECT: SUMMARY OF DECEMBER 9 PUBLIC TELECONFERENCE TO

RECEIVE COMMENTS ON THE WASTE CONFIDENCE DRAFT GENERIC ENVIRONMENTAL IMPACT STATEMENT AND

PROPOSED RULE

On Monday, December 9, 2013, members of the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 3 public teleconference at NRC headquarters in Rockville, Maryland. The purpose of the teleconference was to accept public comments on the Waste Confidence draft generic environmental impact statement (DGEIS) and proposed rule. The facilitated teleconference began at 1:00 p.m. EST and concluded at 4:00 p.m. EST. NRC staff began the teleconference with a brief introduction, and the rest of the teleconference was dedicated to receiving comments from members of the public.

Approximately 71 people participated in the teleconference, and 24 participants provided a total of 36 comments. Participants included representatives from the Florida Public Service Commission; Florida Department of Health; Maine Department of Health and Human Services; Nye, Clark, and Churchill Counties, Nevada; the National Conference of State Legislatures; and members of industry and public advocacy groups. Commenters called in from Pennsylvania, Maine, Georgia, California, Michigan, Florida, Virginia, Tennessee, Illinois, Iowa, Maryland, and Nevada.
