Dear Dr. Bley:

During the 635th meeting of the Advisory Committee on Reactor Safeguards (the Committee, ACRS) held on July 6-8, 2016, the Committee completed its review of the license renewal application for LaSalle County Station, Units 1 and 2 (LSCS). The Committee also reviewed the U.S. Nuclear Regulatory Commission (NRC) staff's final safety evaluation report (SER) for this application.

In the Committee's final report dated July 18, 2016, the Committee recommended that the NRC renew the operating licenses for LSCS. The NRC staff appreciates the Committee's objective and in-depth review of the license renewal application and the staff's final SER. The NRC staff acknowledges the Committee's insights regarding the resolution of the two open items that were closed between the ACRS subcommittee and full committee meetings, as documented in the final SER:

- Assurance that the aging management program for the vessel inner-diameter attachment welds will provide acceptable weld examination coverage and include additional acceptable actions taken in the event of limited weld examination coverage.
- Assurance that the aging management program for stress corrosion cracking will require documented bases for crediting limited coverage weld inspections, to include an engineering technical evaluation.
