SUBJECT: SUMMARY OF JULY 27, 2016, PUBLIC MEETING

TO DISCUSS ADVANCED, NON-LIGHT WATER REACTOR

REGULATORY REVIEWS

On July 27, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16181A321), the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting with the Nuclear Energy Institute (NEI) Advanced Reactor Regulatory Task Force (ARRTF) and other stakeholders to discuss the initiatives within the industry and NRC related to the development and licensing of non-light water reactors. This was the first public meeting with NRC staff and representatives from NEI's ARRTF. A list of individuals attending or participating in the meeting by webinar can be found as an enclosure to this summary. The slides and meeting handouts used by the staff and industry are available in ADAMS under Accession No. ML16222A395.

The staff provided some background information on the development of regulatory review and licensing strategies and activities associated with the draft "NRC Vision and Strategy for Non-Light Water Reactor Mission Readiness," issued for public comment (81 FR 47443; July 21, 2016). The focus of the staff's presentation was to elicit stakeholder feedback on establishing more flexible, risk-informed, performance-based, regulatory review options for advanced reactors, including the use of conceptual design reviews, staged-review processes, and standard design approvals (SDAs). The flexible approaches discussed are intended to accommodate potential applicants having a range of financial, technical, and regulatory maturity, and a range of application readiness.

The NEI presentation provided background information on the focus areas of the ARRTF, with particular attention to the activities of the working group formed to address staged application reviews and approvals. Much of the discussion centered on preliminary results from an NEI survey of advanced reactor developers. NEI plans to refine the survey data to develop industry proposals for a staged process and is considering additional surveys of the developers and related communities such as potential investors.
