During the 641<sup>st</sup> meeting of the Advisory Committee on Reactor Safeguards, March 9-11, 2017, we reviewed proposed Revision 5 to NUREG/BR-0058, "U.S. Nuclear Regulatory Commission Guidance on Performing Cost-Benefit Analyses." Its table of contents lists 12 appendices. However, seven of the appendices consist only of an outline of intended contents. Staff has indicated that these appendices remain under development. The draft NUREG is currently pending issuance for public comment.

We find it reasonable to seek public comments on the draft NUREG, and we plan to provide comments in parallel. Because Revision 5 to NUREG/BR-0058 refers to the appendices, conforming changes are expected to be required as the appendices are completed. The Committee should have another opportunity to review Revision 5 to NUREG/BR-0058 after all appendices are completed and prior to its issuance.
