Disc (part number 8205-012) in 4NPS Class 150 through 900 Swing Check Valve

Gentlemen,

Ameren, former Union Electric, informed us in November 2017 during a service inquiry that they are dealing with a swing check valve disc that was found stuck in the open position during their post refueling testing at Callaway Nuclear Power Plant. The disc in question was delivered in 1997 and installed in 1999; the valve is subject to leak surveillance by test once every 18 months. The valve failed its last test and was open for examination at which time the disc was found stuck open.

Our internal investigation determined the following:

- There was a design change in 1979 which increased the thickness of the disc in order to make it suitable for larger pressure classes, from 600 up to 900 and 1500;
- 3D modelling revealed that as a result of the disc configuration there is a chance that the disc edge will contact and bind with the wall of the valve before the stopper at the end of the hanger hits the wall of the valve and prevent this from happening
- The part number was left unchanged;
- The corresponding enlarging of the body cavity was done only in 1985;
- Our internal records go back to 1982; an examination of these records reveals that we shipped 157 discs of this part number, to the US utilities identified in Annex 1 and 2; these records come from two different systems, hence their slightly different appearance/content.

The following actions are being taken with respect to the disc:

- Cancel disc part number 8502-012
- Create a new disc part number to fit the body geometry of 1985 and before
- Create another disc part number to fit the current body geometry.

All utilities in the attachment will be notified within a week, for information and to determine a course of action. As a minimum, Velan will recall all discs of the aforementioned part number in inventory at these utilities.
