Subject: Error Notification for a Reportable Bug In PD (EPD) STRUDL.

Dear Sir/Madam:

Enclosed please find the reportable bug, B6.0-267, in PD (EPD) STRUDL. PD (EPD) STRUDL is a proprietary program, owned and distributed by Phi-Delta, Inc. The program may be used to analyze and/or design structural components in Nuclear Power Plants, including but not limited to:

1. Piping,
2. Suspended systems,
3. Baseplates,
4. Other general miscellaneous structures and
5. Etc., etc.

The bug was reported to all known users of Piping portion of the program because it affected only the Piping Application. The bug was distributed using Phi-Delta Quality Assurance Procedures' Manual (PDQAPM), Edition 5, Revision 0 (ESR0) on or around **August 28, 2017**. Per our procedures, the reportable bug is distributed using the United States Postal Service (USPS) with Return Receipt requested. The returned receipt is used to assure that the user has received the bug.
