## **INSTRUCTIONS TO STUDENTS**

<u>ACCEPTANCE</u>: Individuals listed in Enclosure 1 have been accepted for participation in the Visual Sampling Plan (H-500) course. This course is scheduled to be presented November 13-16, 2018, at the Ohio Department of Health. The training will take place in the OMIS Training Room B. The OMIS is located at 35 East Chestnut Street, Columbus, OH 43215. The on-site training contact is Michael Snee, (614) 644-2732.

**COURSE**: Please see our website, <a href="https://scp.nrc.gov/training.html">https://scp.nrc.gov/training.html</a> for the Tentative Course Schedule and note that the course begins at 8:00 a.m. on Tuesday, November 13 and ends at 12 noon on Friday, November 16.

**LODGING AND TRAVEL:** Please plan to arrive on Monday, November 12 and depart on Friday, November 16. Students must make their own lodging and travel arrangements. If traveling by air, please contact El Sol Travel at (844) 244-6694 for airline reservations, and indicate that the travel is "Invitational" for the NRC. Please select a fully refundable government fare if one is available, and make sure that El Sol Travel correctly direct bills your fare to credit card ending 2835. If the need arises and you must make a change, contact Karen Meyer at (301) 415-0113.

Please complete the Travel Application Form which will be provided to you and submit to <a href="AStrainingandtravel.Resource@nrc.gov">AStrainingandtravel.Resource@nrc.gov</a>, at your earliest opportunity, but no later than Friday, November 2<sup>nd</sup>. Individuals should request the Federal government rate at the hotels. The per diem for Columbus, Ohio is \$122 for hotel and \$61 for meals and incidentals. The first and last day of travel is calculated at 75 percent. Students will be responsible for their own transportation between the hotel and the training center. If you are authorized to drive, the Federal mileage reimbursement is .545 cents per mile. Rental cars are not authorized for reimbursement.
