ISSUANCE OF PROPOSED RULE AND NOTICE OF AVAILABILITY OF THE DRAFT REVISED GENERIC ENVIRONMENTAL IMPACT STATEMENT FOR LICENSE RENEWAL OF NUCLEAR PLANTS (NUREG-1437, DRAFT REVISION 2) (STC-23-012)

Purpose: To inform States and Federally recognized Indian Tribes that the U.S. Nuclear Regulatory Commission (NRC) has published a proposed rule for public comment to amend the regulations that govern the NRC's environmental reviews of operating license renewal applications for nuclear power plants under the National Environmental Policy Act.

Background: The proposed rule titled "Renewing Nuclear Power Plant Operating Licenses – Environmental Review" would codify the revised generic findings of NUREG-1437, "Generic Environmental Impact Statement for License Renewal of Nuclear Power Plants," Revision 2 (LR GEIS) in Part 51 of Title 10 of the *Code of Federal Regulations* (10 CFR Part 51), "Environmental Protection Regulations for Domestic Licensing and Related Regulatory Functions." Additionally, the NRC is issuing for public comment the draft revised LR GEIS and associated guidance contained in Draft Regulatory Guide-4027, Supplement 1, Revision 2, "Preparation of Environmental Reports for Nuclear Power Plant License Renewal Applications," and Draft NUREG-1555, Supplement 1, Revision 2, "Standard Review Plans for Environmental Reviews for Nuclear Power Plants, Supplement 1: Operating License Renewal."

The LR GEIS analyzes the potential environmental impacts that may result from continued operation of a nuclear power plant during the renewal term (initial or subsequent license renewal). The purpose of the LR GEIS is to identify and evaluate environmental issues that could result in the same impact at all nuclear power plants (or a distinct subset of plants) (i.e., generic issues) and determine which issues could result in different levels of impact (i.e., nuclear plant-specific issues). For the issues that cannot not be evaluated generically, the NRC conducts nuclear power plant-specific environmental reviews and prepares plant-specific supplemental EISs to the LR GEIS. The NRC also considers any new and significant information for generic issues.

Discussion: Enclosed is the *Federal Register notice* "Renewing Nuclear Power Plant Operating Licenses – Environmental Review; Proposed Rule," 88 FR 13329 (March 3, 2023) requesting public comments on the proposed rule, draft revised LR GEIS, and associated guidance. If you wish to provide comments, please send via one of the methods below by May 2, 2023. Comments received after this date will be considered if it is practical to do so, but the NRC is only able to assure consideration for comments received on or before May 2, 2023.
