I worked at Surry Nuclear and at North Anna Nuclear Power Plants On shutdown's, and I saw a lot of new large in diameter size copper wire cut in long 6 feet to 14 feet length's weighing hundreds of pounds sent to the landfields. This was done on a 7 day 24 hour work week for the 30 days that I was there. I hooked the large dumpsters to the crane to be loaded on the trucks, until I asked to many questions and was then laid off, I was the only one laid off at the time. I am not mad bought getting laid off. The reason I'm saying this is someone is stockpiling with our money. You do know that the landfields will be auctioned, Ser, this copper is not scrap it's all new wire. Sir, I called some people before bought this and was told that for this kind of information I could be killed, so for a long time I've been silent. The amount of wire I saw was enough to build a new power plant at each site. I have more than 25 years experience in construction. If you would like to talk more bought this please call or E-mail.
