
On December 7, 1999, the NRC completed an inspection of your Braidwood Generating Station, Units 1 and 2. The enclosed report presents the results of that inspection.

The inspection was an examination of activities conducted under your license as they relate to implementation of your NRC-approved physical security plan and to compliance with the Commission's rules and regulations and with the conditions of your license. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Security force performance continued to be good. Transition to a different security contractor, and implementation of a new plant protection strategy were effective.
