Current Status

- ◆ Industry review of Revision 2, Draft 2 almost complete
 - 62 of the 72 Chapters/Sections have been reviewed and comments received
 - Remainder forthcoming
- ◆ 224 of 231 approved TSTFs incorporated
- ◆ All Revision 1 Editorial Comments reviewed and transcribed to Rev. 2 pages

General Comments

- ◆ Posting and retrieval of Adobe Acrobat files went smoothly
- ◆ Number of comments is substantially reduced from last round of review
- ◆ Only a few new problems
- ◆ Much improved
- ◆ Clearly approaching a finished product

Process Comments

- ◆ Many reviewer's identified problems with the approved TSTFs. Need mechanism to address these issues expeditiously
- ◆ No documentation exists on the format changes discussed between the NRC and the TSTF. As a result, many comments on items such as Bases headers, lack of "continued", page number format, and brackets. TSTF will disposition before transmittal of comments.

Process Comments

◆ Adobe Acrobat Files

- Posted files cannot be searched or have text pasted into other documents
- Not a problem in Draft 1
- Known Acrobat 4 problem with fonts
- EXCEL will work with NRC to resolve so that final files contain usable text

Examples of Problems Found

◆ Technical Comments

- Technical changes made to the NUREGs with no associated Traveler
 - Words added to CEOG Safety Limit
 - BWOG definition of QPTR revised
 - BWROG EDG voltage values changed
- ◆ Need to document and get TSTF concurrence of these changes
- Need to address adoption of standard Criterion 4 discussion
 - ◆ TSTF will propose editorial to address

Examples of Problems Found

◆ Traveler Comments

- Some Travelers only partially incorporated, or “editorialized”
- Many problems in incorporating TSTF-8
- TSTF-9 listed in NRC matrix but not incorporated
- TSTF-125, Rev. 1, approved by NRC on 4/21/98 but not in matrix or incorporated

Examples of Problems Found

◆ Format Comments

- Still instances of "bisTable" and "accepTable"
- The "readme" file posted with the NUREGs stated that the itemized list format had been revised to be more consistent. However, changes were not made consistently
 - ◆ Sometimes semicolons remain, sometimes commas are used, sometimes there is no punctuation at the end of a list item
- Double lines missing at the end of some sections

Examples of Problems Found

◆ Format Comments

- New brackets are not used consistently
 - ◆ i.e., Many bracketed SRs do not have the SR number within the brackets
- Indenting and alignment problems
- Many missing spaces, resulting in words running together
- Many pages still labeled "Rev. 1"
- Appears some non-breaking spaces have been removed, such as between "MODE" and "1" resulting in inappropriate line breaks

Completion of Revision 2 Review

- ◆ All future changes should be restricted to:
 - Incorporating comments
 - Incorporating approved Travelers
- ◆ Industry to do focused review of changes only

Completion of Revision 2 Review

- ◆ Need schedule for approval, incorporation, and review of remaining Travelers agreed to be in Revision 2
- ◆ Need to issue revised Writer's Guide with Revision 2 to document format changes

White Paper 1

(2st Page: Why change the STS format.

3rd Page: Heading Styles for STS

4th Page: ToC example

5th Page: Other Styles for STS.)

(1) Problem Statement:

1. Titles for Chapters and Sections are in all caps, a convention reserved for defined terms.
2. A Chapter number (3.0) is given to two Sections, that have different titles.
3. Specifications use defined and non defined terms such that mixed formats exist, all caps and initial capitals, which since it is not stating are requirement need not use all caps for terms that are defined.
4. Note styles and Action Table and SRs Table headings use all caps, again a convention reserved for defined terms.
5. Sections and Specifications Titles are inconsistent, some underlined - some are not.
6. Topic heading in the Bases are underlined.
7. All abbreviated forms are in all capital letters, can not distinguish if it is for defined term or not.

Reason for Change:

1. Consistency with the convention for defined terms.
2. Consistency of using different numbers for different sections.
3. Avoid underlined text which is inconsistent with use for HTML (underline means a hyperlink for those with visual disabilities that can not distinguish such from the color blue.)
4. Put abbreviated forms for defined terms in italics.

Reason for Change

1. Repeat of item 2 of White Paper 1 above.
2. Change Titles to reflect content, avoid duplication of title for a Chapter and one of its Sections.

Integrated Industry / NRC Priority List

Significant Regulatory Issues Being Followed by the NRC and the TSTF for Which a Traveler has Not Yet Been Created:

Low or No Safety Significance Verbatim Compliance Issues - The NRC acknowledges that the words in the old custom, the old standard and the ITS are not perfect. The NRC and Industry have spent an inordinate period of time on literal or verbatim compliance issues that have little or no safety significance. The NRC wanted to know if the TSTF is considering proposing generic fixes to these kinds of issues. Some generic/motherhood fixes could address many of these issues - especially "during testing" and "during realignment." The NRC would entertain a generic or issue specifically a change or group of changes to address low significance verbatim compliance issues. TSTF to consider an action to address these issues. Bryan Ford specifically addressed the BWR secondary modes of operation issue and asked for the opportunity to meet with TSB/RBB during the 12/16 - 12/17, 1998 timeframe - Mark R/B. Ford to discuss. B. Ford would like some information on changes considered to address not declaring equipment inoperable and taking the actions when the equipment is made inoperable during surveillance testing.

4/19/99 - TSTF is continuing to evaluate the need for generic resolution for the types of issues that may arise and is working with the NEI License Amendment Task Force (LATF) to develop an LCO 3.0.8 to address one aspect of these issues. TSTF is also working to find other resolutions.

TSTF/Industry Initiative to Address TSTF Adoption by Converted Plants - The NRC and Industry discussed the industry draft Administrative Letter. The TSTF will provide the Admin Letter to the NRC after TSTF and Owner's Group review in Feb and March, 1999. NRC wants a focus group meeting with the TSTF within 1 month of receipt of the Admin Letter to resolve the process.

7/16/99 - Admin letter provided to the NRC.
