This letter definitizes Modification No. 1 to Task Order No. 3, which provides incremental funding in the amount of \$300,000.00. Accordingly, Task Order No. 3 is modified as follows:

Paragraph 5 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"The amount currently obligated by the Government with respect to this task order is \$525,000.00, of which \$479,452.00 represents reimbursable costs and the amount of \$45,548.00 represents fixed fee. It is estimated that the amount currently allotted will cover performance through November 30, 2000."
