Gentlemen:

Pursuant 10CFR50.71(e), Entergy Operations, Inc. (EOI) herein submits one signed original and ten copies of Revision 12 changes to the River Bend Station (RBS) Updated Safety Analysis Report (USAR). The Revision 12 submittal depicts the effects of changes made in the facility as described in the USAR. This revision to the USAR covers changes made during the period May 1, 1998, until startup from Refuel Outage 8 (July 3, 1999).

In addition to USAR, Revision 12, EOI submits the 50.59 Summary Report pursuant to 10CFR50.59(b)(2). The 50.59 Summary Report contains a brief description of changes, tests, and experiments, along with a summary of the safety evaluation performed for each. The Summary Report is provided to meet the requirements of 10CFR50.71(e)(2)(ii) for identification of changes made under the provisions of 10CFR50.59 but not previously submitted to the Commission. The 50.59 Summary Report also includes summaries of the safety evaluations performed in support of license amendments to the Technical Requirements Manual.

The changes have been processed and documented according to RBS procedures. In addition, Revision 12 of the USAR incorporates a number of editorial changes to a) correct typographical errors, incorrect references and grammar; b) clarify without changing the meaning; c) move information to a more appropriate location; and, d) make USAR sections consistent with other USAR sections or licensing documents. The editorial changes have been documented according to procedure, evaluated, and determined to not involve an unreviewed safety question.

Pursuant to 10CFR50.71(e)(5), each replacement page in Revision 12 includes change indicators in the specific text area changed and a page change identification in the form of a date change (December 1999) that appears at the bottom of each page changed. The revision change indicators are special symbols that occur before  $(\bullet \rightarrow)$  and after  $(\leftarrow \bullet)$  the area changed.

In accordance with 10CFR50.71(e)(1), a list of effective pages is included to identify the current pages of the USAR after incorporation of Revision 12 changes. Directions for inserting the page change outs are provided detailing the replacements, additions and deletions.

Additionally, replacement pages for the RBS Technical Requirements Manual (Appendix 16A of the USAR) are included for changes made since the last submittal in April 1998. The TRM replacement pages cover changes made during the period from November 1, 1997, through Refuel Outage 8. A list of effective pages is included to identify the current pages of the TRM after incorporation of the present revision.

As required by 10CFR50.71(e)(2)(i), the attached affirmation certifies that the information in the revisions to the RBS USAR as well as the 50.59 Summary Report accurately reflects changes made since the previous submittal necessary to represent information and analyses submitted or prepared pursuant to NRC requirements.
