On December 21, 1999, PECO Energy Company ("PECO"), Public Service Electric and Gas Company ("PSE&G"), PSEG Nuclear LLC ("PSEG Nuclear"), Atlantic City Electric Company ("ACE"), and Delmarva Power & Light Company ("DP&L") submitted a joint Application for License Transfers and Conforming License Amendments ("the Application") requesting NRC consent to the transfers of the non-operating ownership interests of ACE and DP&L in the Peach Bottom Atomic Power Station, Units 2 and 3 to PECO and PSEG Nuclear, and approval of the conforming amendments of the Peach Bottom operating licenses to reflect the ownership transfers.



I, Mark B. Bezilla, being duly sworn, state as follows:


1. I am Vice President, Nuclear Operations of PSEG Nuclear LLC ("PSEG Nuclear") and PSE&G.
2. Atlantic City Electric and Delmarva Power and Light have agreed to transfer certain minority, non-operating ownership interests in Peach Bottom Atomic Power Station, Units 2 and 3, to PSEG Power LLC. PSEG Power intends for those interests to be transferred to PSEG Nuclear.
