I am responding to your letter dated November 9, 1999, to former Chairman Dicus and Members of the Commission, expressing your concerns about the continued operation of the Millstone nuclear power plants. There were extensive changes in management at the operating facilities and at Northeast Nuclear Energy Company (NNECO) in general. Our confidence in the new managers was an important factor in evaluating the commitment NNECO has made to ensure the safe operation of their licensed facilities. Even though the Millstone units have been authorized to operate, the NRC continues to provide extra resources to maintain an ongoing assessment of the licensee's performance. Specifically, the NRC formed the Millstone Assessment Panel (MAP) to not only assess the licensee's performance, but also to provide oversight of NRC activities, make recommendations for enhanced inspection activities, provide NRC management and the Commission with periodic status reports, and conduct periodic public meetings with NNECO and their contractor, Little Harbor Consultants, to discuss licensee performance.

In your letter you also raised concerns about Millstone and the continued lack of an emergency management plan for Eastern Long Island. As noted in my previous letters, proposals have been made to both increase and decrease the 10-mile emergency planning zone (EPZ) distance since this policy was established following the accident at Three Mile Island in 1979. After consideration of these proposals and their supporting documentation and rationale, the Commission has consistently concluded that an EPZ of about 10 miles in radius provides an acceptable planning basis for emergency response.

The bases for the Commission's policy in response to requests to expand the 10-mile EPZ are found in the February 16, 1990, Federal Register notice (55 FR 5603) denying a petition for rulemaking, and in a decision regarding emergency planning in support of issuance of the operating license for Shoreham Nuclear Power Station (26 NRC 383 (1987), CLI-87-12). These references are available through the NRC Public Document Room, e-mail "PDR@nrc.gov," or 1-800-397-4209. There is a minimal charge of \$0.08 per page of printed material. The Federal Register notice is 12 pages, and the CLI-87-12 is 17 pages.

NNECO is assisting each of the five east end towns of Long Island and Suffolk Counties with creating a coordinated emergency plan and establishing an open line of communication to ensure that Eastern Long Island is considered when decisions are made regarding the Millstone plants. I encourage the communities involved to continue the ongoing dialogue with NNECO, as well as appropriate State and county officials, to develop the plans they believe are needed.

Again, I assure you that the NRC continues to monitor the performance of Millstone to ensure that public health and safety are adequately protected. The NRC is committed to the level of
