The purpose of this modification is to:

1. Decrease the contract ceiling amount by \$45,554.36 from 599,818.00 to \$554,263.64.
2. Revise Subsection G.1, entitled, "Indirect Cost Rates," to incorporate the final negotiated indirect rates identified in the Defense Contract Audit Agency Report No. 1701-99W10250004.

Accordingly, the contract is hereby modified as follows:

- (1) Under Section G - Contract Administration Data, Subsection G.1 - Indirect Cost Rates is deleted in its entirety and the following is substituted in lieu thereof:

"G.1. INDIRECT COSTS RATES

For this contract, the maximum allowable indirect cost rates for reimbursement of indirect costs are as follows:

ALTERNATE I (JUN 1991)

- a. The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is \$554,263.64.
- b. The guaranteed minimum obligated by the Government under this contract is \$554,263.64."

All other terms and conditions under this contract remain unchanged.
