This modification deobligates excess funds in the amount of \$3,891.33. Accordingly, the contract is modified as follows:

1. Section B.3, "Consideration and Obligation - Cost Plus Fixed Fee", subparagraphs (a) and (c) are revised to read as follows:

"(a) The total estimated cost to the Government for full performance of this contract is \$118,474.67, of which the sum of \$109,690.67 represents the estimated reimbursable costs, and of which \$8,784 represent the fixed fee."

"(c) The amount obligated by the Government with respect to this contract is \$118,474.67."

All other terms and conditions of the contract, including the ceiling amount of \$122,366.00, remain the same.
