**SUBJECT: NRC INSPECTION REPORT 50-237/99022(DRS); 50-249/99022(DRS)**

Dear Mr. Kingsley:

This refers to the security inspection conducted between December 13-17, 1999, at the Dresden Nuclear Power Station. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC security related requirements.

During this inspection period, the overall performance of the security organization, except as noted in this report, was sound. Security personnel were knowledgeable of their duties, and generally demonstrated proper implementation of security requirements. Station management activities were focused toward maintaining an effective security program. Inspected security equipment functioned as designed.

Based on the results of this inspection, the NRC has determined that three violations of NRC requirements occurred. These violations are being treated as Non-Cited Violations (NCVs), consistent with Appendix C of the Enforcement Policy. These NCVs are described in the subject inspection report. If you contest the violations or severity levels of these NCVs, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001, with copies to the Regional Administrator, Region III, and the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001.

Areas examined during this inspection concern a subject matter which is exempt from disclosure according to Part 73, Title 10, Code of Federal Regulations, Section 73.21. This information must be handled and protected in accordance with the provisions of 10 CFR 73.71.
