Contract NRC-10-96-155 is hereby modified to provide an equitable adjustment for the fourteenth floor changes directed in modification seventy-four (74). Accordingly, the following changes are hereby made to the subject contract:

Section B.4 CONSIDERATION AND OBLIGATION—FIRM FIXED PRICE is modified to increase the fixed price of the contract by \$9,300 from \$5,486,123 to \$5,495,423.

In consideration of Modification Eighty-Seven, the Contractor hereby releases the Government from any and all liability under this contract for further equitable adjustments attributable to such facts or circumstances giving rise to the Contractor's proposal for adjustment dated October 26, 1999.
