Gentlemen:

In accordance with 10 CFR 55.57, Carolina Power & Light (CP&L) Company is submitting seven license renewal applications consisting of NRC Form 398, "Personal Qualification Statement - Licensee," and NRC Form 396, "Certification of Medical Examination by Facility Licensee." The renewal applications are being submitted for operators licensed on CP&L's Brunswick Steam Electric Plant (BSEP), Unit Nos. 1 and 2, at least thirty days before the expiration of the existing licenses, as required by 10 CFR 55.55.

Enclosure 1 provides a list of the individuals applying for license renewal, including their respective docket numbers, license numbers, and expiration dates for the current licenses. In accordance with 10 CFR 55.57(a)(2), Enclosure 2 provides the original and two copies of NRC Form 398, including the number of the license for which renewal is sought.

In accordance with 10 CFR 55.57(a)(3), CP&L is providing a copy of NRC Form 398 as evidence of the applicant's experience under the existing license. Also included is the approximate number of hours that the applicant has operated the facility. In accordance with 10 CFR 55.57(a)(4), CP&L certifies that during the effective term of the current license, the applicant has satisfactorily completed the requalification program for BSEP, Unit Nos. 1 and 2. In accordance with 10 CFR 55.57(a)(5), CP&L certifies that the individuals have discharged their license responsibilities competently and safely. In accordance with 10 CFR 55.57(a)(6), Enclosure 3 provides the original NRC Form 396 for the individuals. The NRC Form 396 provides CP&L's certification of the medical condition and general health of the individual seeking renewal of their license as required by 10 CFR 55.21, 55.23, and 55.27.
