**SUBJECT: KEWAUNEE INSPECTION REPORT 50-305/2000001(DRS)**

Dear Mr. Marchi:

This refers to the security inspection conducted between January 10-14, 2000, at the Kewaunee Nuclear Power Plant. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC security related requirements.

During this inspection, security program performance was good. Except as noted in this report, security personnel were knowledgeable of their duties and responsibilities, and demonstrated proper implementation of security requirements. Station management activities were properly focused toward maintaining the security program. Maintenance activities contributed to maintaining an effective level of performance and reliability of security equipment inspected.

Based on the results of this inspection, the NRC has determined that one violation of NRC requirements occurred. The violation is being treated as a Non-Cited Violation (NCV), consistent with Appendix C of the Enforcement Policy. The NCV is described in the subject inspection report. If you contest the violation or severity level of the NCV, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001, with copies to the Regional Administrator, Region III, and the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001.

Areas examined during this inspection concern a subject matter which is exempt from disclosure according to Part 73, Title 10, Code of Federal Regulations, Section 73.21. This information must be handled and protected in accordance with the provisions of 10 CFR 73.71.
