
**JOINT REQUEST TO MODIFY DEPOSITION  
SCHEDULE FOR UTAH CONTENTION H**

On January 24, 2000, Applicant Private Fuel Storage ("PFS") filed a "Joint Request for Modification of Discovery Schedule for Depositions" on behalf of itself and the State of Utah to request, among other things, the deferral of depositions for Contention Utah H to the week of February 21, 2000. Unexpected complications arose, however, in scheduling the depositions for that week. The State and PFS have therefore worked out and agreed upon new dates for the depositions, specifically March 8 and 9, 2000. The State and PFS have confirmed the availability of all four deponents for these dates. Accordingly, PFS and the State respectfully modify their previous joint request to the Board for "Modification of Discovery Schedule for Depositions" to allow the depositions of Dr. Marvin Resnikoff and Matthew R. Lamb (the State's witnesses for Utah H) and of Dr. Kris Singh and Dr. Indresh Rampall (two of PFS's witnesses for Utah H) on March 8 and 9, 2000.


